Merry Christmas and Happy Holidays to you all. Stay safe and enjoy the Wisconsin winter.



Don't Eat Yellow Snow

Well, that got your attention. What does the average six-year-old, the mailbox at your house, and Wisconsin snowfall have in common? Don't overthink it. The answer is 45 inches. That's the average height of the first two, and the average annual snowfall in central Wisconsin for the third.

When that snow melts, that's the equivalent of about 4 inches of water, or a half million gallons, that flows off a five-acre auto recycling facility to the nearest lake or stream.

But that's not crystal clear snowflake water. Snowmelt carries pollutants that have accumulated in the snow throughout the winter. That includes airborne contaminants, deicing chemicals (salt and additives), anti-skid grit (sand), oil and grease (slush washing the undersides of vehicles and your equipment), metal wash off, and sediments eroded from thawing unpaved roadways in early spring. Vegetation is dormant and there's less infiltration (natural cleansing) into the soil. Frozen catch basins and ice-blocked channels result in shallow ponded water that causes more erosion and resuspension of sediments.

Snowmelt runoff in early spring can contribute to the deterioration of water quality because these elevated levels of pollutants are being discharged to sensitive waterways. Rivers and lakes awaking from freezing are frail ecosystems. Food supplies are sparse, nutrient cycles are slowly developing, and fish and other aquatic life are starting to reproduce.

Here are some suggestions on what you can do to minimize the adverse impacts of snowmelt:

- Spring cleanup: Start sweeping as soon as snow is off the pavement. Clean out catch basins and replace the filters. Clear ice blockages. Clean up debris left by melting snow piles.
- Control erosion: Bring in stone or crushed rock to stabilize muddy unpaved roadways. Temporarily minimize equipment traffic in erosion-prone areas, includ-

ing roads with ponded water. Stabilize eroded channels with mulch, geotextile fabric, or rock. Revegetate as soon as suitable weather occurs.

- Minimize use of deicing salts and chemicals, or perhaps stated another way, don't use excessive amounts of deicers beyond what you need for the safety of your employees and customers.
- Keep your outfalls clean: Your outfalls are where storm water is discharged from your facility. Do not place extra equipment or debris at your outfalls. These are also not good places for your snow piles. Your outfall locations should be the cleanest parts of your facility.
- Maintain your storm water treatment systems.
 Spring is a good time to replace absorbent booms, filter fabrics, and filter media (sand, peat, zeolite). Ponds work year-round, although the sedimentation may be less effective in spring due to more dissolved and fine-particle pollutants.

A good goal is for your spring snowmelt to be just as clean as your rainfall runoff is during the rest of the year. I'd like to think that taking these precautions can help our 45-inch-tall, six-year-old kids enjoy safe drinking water, care-free swimming, and rewarding fishing for years to come.

Conrad's Auto Salvage Open House

It has been a busy one at Conrad's Auto Salvage, Inc this year. On March 19th we started the expansion. The first building to go up was our fluid recovery building. The car will come from inventory and go into here where all fluids, wheels and tires will be taken from the vehicle at this point. The vehicle will then move into the teardown facility for dismantle. This will take some time to get through current cars that are still waiting to be processed but it's always good to start somewhere.

The next building to go up was a 60x80 cold storage shed to house motors and tranny's. This was added to the building plan when old man winter decided to take down a lean to.

The last building on the plan was our shipping/receiving production offices. The upper level contains offices for Jerry and Jenny and a conference room for meetings and to allow other groups to utilize the space if need be. The lower level contains two offices one for Cody - production manager and the other for Nick in dispatch. Also on this level is a small part shipping room with an overhead door for UPS and SpeeDee drivers to utilize. There are three bays to park our delivery trucks in at night and get loaded and ready for deliveries. The fourth bay at the front of the building is for LTL shipments. Our yard personnel have a service door as well as an overhead garage door for bringing parts in. We have a wash bay system with an ESD750 system that was installed.

This will reuse water from washing of our parts to save on the environmental waste. Parts will come out of our teardown bays to small part inventory to be tagged and pictured. Our office, shipping/receiving/cold storage, and teardown were all tied together and we installed restaurant style doors that open both ways so that carts can be pushed from teardown to storage without going outdoors.

Our facility, from the road to the entire area in front of the office/shipping/ and teardown, was blacktopped for cleanliness and ease of operation.

On August 28th Cody's son and our grandson Cole was born. Cody, Jenny and Jerry attended the ARA convention in Charlotte, NC on October 10-12th. On October 19th Jerry and Jenny tied the knot (finally after 15 years).

The expansion finished up with an open house on October 25th and 26th. We welcomed a little over 400 fellow recyclers and community members into the facility for food and tours. Pete Krumenauer was presented with 20 years of service to CARS of WI plaque at the open house.

We can't thank everyone enough for all of their hard work and dedication through the entire process this year.

Employees – A Company's Best Asset

Focus on Fundamentals Part 2 of a 5-part series*

In my role with ARA as a mentor, I created some basic instructions for Recyclers that I am mentoring. After looking at this first one, I said to myself, "This is something that is relevant and of use to all recyclers, myself included." I think that we all from time to time need to focus on our fundamentals. It gets very easy to lose sight of this. I also think that simpler is better and less is more.

While this will show up on any Balance Sheet or Financial Statement as an expense, your company's most valuable asset is your people. They represent your company and project an image of who you are and what you do. This image and perception can be either positive or negative.

The employees in your company make up your team. Nobody can win without a good team. Let's talk about the importance of good leadership.

For any business to be successful, strong leadership is a must. The best leaders lead by example. They can train, teach, and develop. They also make others around them better. They byproduct of all of this is a good workplace culture.

Here is one example of how important good leadership is. As I am a hockey player, I'm going to give you a recent example. The St. Louis Blues in January, 2019 were the last place team in the NHL. Fast-forward to today; they have now advanced to the Stanley Cup Finals as one of the last 2 teams left in competition for the most difficult trophy to win in all of professional sports. So, what brought about this dramatic change? They made a change in leadership in November of 2018. They had the same players, so it's pretty obvious that this coaching change that was made was the reason for this turnaround.

This is only one example of many that you would find. And this is also the biggest factor that can enhance a company's success. It is also important for a company to find a healthy balance between taking care of their employees well and remaining profitable. Without good employees, you will be limited in your ability to provide good customer service and secure your future. You have to focus on the big picture here.

Fair compensation: Pay what the job is worth. This usually means that you are paying enough when the issue of money is not on the table. Fair compensation equals less turnover and better, happier employees. Provide your employees with the training, resources, tools, and whatever else is needed for them to be successful. All good employees have the same needs. Besides ample compensation, everyone has a need for self-fulfillment and to feel that they are relevant and appreciated.

Any business that has a short-sighted approach and trims cost at their employees' expense will most certainly realize that this was a bad decision. This will also have a bad effect on the company's bottom line. In this day and age, they say that people aren't loyal. I disagree. Ask yourself this, "Why should an employee be loyal and dedicated to a company when the company does not do the same for them?"

So what makes a good employee?

- Responsibility
- Dependability
- Dedication
- Respect
- Sense of teamwork
- Pride in what they do and how they do it

So how do you build this team?

Be selective in who you hire. I have a saying: Hire character, not characters. Have your interview process tailored specifically to the job for which you are hiring. Make sure they have the ability and the desire to do that job. Remember, when hiring a new person, you can teach them the job but you can't fix bad character. Also remember that any new

employee is only going to be as good as you make them. Proper training is a must. It is also costly, but so is turnover. So, choose, hire, and train people with the intent that they will be with you for a long time.

When bringing in a new employee, chemistry with existing employees must also be considered. Also keep in mind that attitudes are contagious. People's attitudes, whether good or bad, have a huge effect on people around them. The best way to build and keep this good team is to manage different personalities. Encourage good attitudes and deal with bad attitudes before they become a big problem.

To sum up everything I said, the employees of a company are a direct reflection of its leadership. Just like in sports, strong, hard-working, dedicated leaders will attract and retain the best people and get the best out of them. Poor leadership will do the opposite. They will only be able to attract poor and under-performing people. Consistency and continuity are crucial to the success of any business. The best companies have the best leaders and the best people.

Remember, stick to the basics, keep it simple. Focus on proper, consistent execution of your fundamentals.
